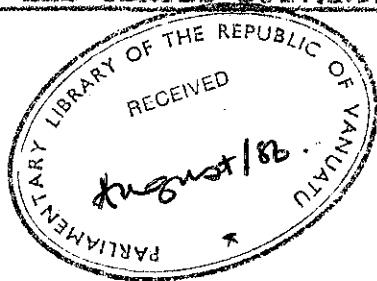

LOCAL GOVERNMENT COUNCIL (PENTECOST) (AMENDMENT NO. 1)
ORDER NO. 31 OF 1986

To amend the Local Government Council (Pentecost) Order No. 54 of 1983 by providing for two new appointed members to the Pentecost Local Government Council.

IN EXERCISE of the power contained in section 5(c) of the Decentralisation Act No. 17 of 1980, as amended, I hereby make the following Order:-

- AMENDMENT OF LOCAL GOVERNMENT COUNCIL (PENTECOST) ORDER NO. 54 OF 1983
1. The Local Government Council (Pentecost) Order No. 54 of 1983 is amended by deleting the names of ADAM BULESIBAT and RAPHAEL BULEARE and substituting therefor the names of WATAS TELKON and TABIUSU PIERRE both representing custom chiefs.

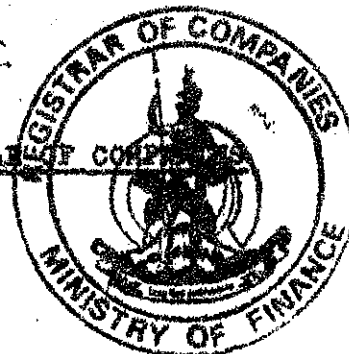

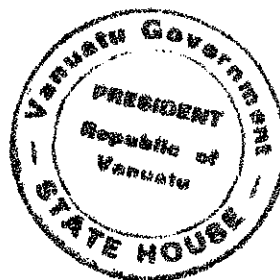
PRESIDENTIAL ORDER
