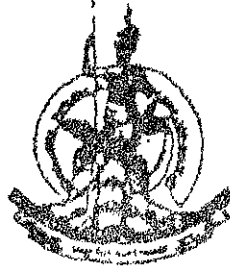

IN EXERCISE of the powers contained in section 7(1) of the Business Licence Act No. 25 of 1983, as amended I hereby make the following Order:

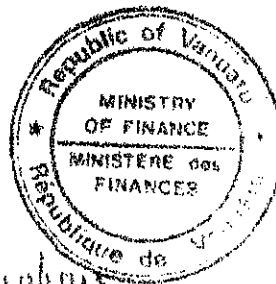
LOCALISATION OF CATEGORY E5 BUSINESSES IN VANUATU
