THE LAND LEASES (AMENDMENT) ACT NO.10 OF 1987

An Act to amend the Land Leases Act No.4 of 1983.

BE IT ENACTED by the President and Parliament as follows:-

**AMENDMENT OF ACT NO.4 OF 1983**

1. The Land Leases Act No.4 of 1983, as amended, is further amended in the Schedule -

(a) by repealing paragraph (1) and substituting the following paragraph -

"Amount of fees

| (e)                                     | by substituting in paragraph 3(f) for the figure "1(e)" the figure "1(d)".  |

**"Montant des droits"**

a) création d'un bail 2%

b) cession d'un bail 2%

c) création et cession d'une hypothèque 0.5%

d) regroupement et subdivision 5%;

b) en insérant au paragraphe b) de l'article 3, après le mot "Administration" les mots "et tout conseil provincial ou municipal sont exemptés" et enlevant les mots "est exempté";

c) en remplaçant au paragraphe d) de l'article 3, le chiffre "100.000 VT" par "50.000 VT";

d) en remplaçant au paragraphe e) de l'article 3) les mots "l'alinéa b) du paragraphe 1)" par "l'alinéa d) du paragraphe 1)" ;

e) en remplaçant au paragraphe f) de l'article 3, les mots "l'alinéa e) du paragraphe 1)" par "l'alinéa d) du paragraphe 1)".

An Order to prescribe the official time of operation at Bauerfield Airport and Pekoa Airport.

IN EXERCISE of the powers conferred by section 3(1)(p) of the Civil Aviation Act No. 38 of 1982, I hereby make the following Order:-

**OFFICIAL HOURS**

1. "Official hours" means the hours of operation at Bauerfield and Pekoa Airports between 0600 hours to 1800 hours local time.

**COMMENCEMENT**

2. This Order shall come into force on the 1st day of September, 1987.

**THE CIVIL AVIATION (SPECIAL LANDING AND  
TAKE-OFF FEES) (REGULATIONS) ORDER NO. 42 OF 1987**

An Order to prescribe fees in respect of aircrafts landing and taking-off at Bauerfield Airport and Pekoa Airport outside official hours.

**IN EXERCISE** of the power conferred by section 3(1)(p) of the Civil Aviation Act No. 38 of 1982, I hereby make the following Order:-

**FEES**

1. (1) Subject to section 2, the various fees specified below shall be payable in respect of every aircraft and in the circumstances as described for each landing or take-off outside the official hours at Bauerfield Airport and Pekoa Airport:-

<u>Particulars</u>	<u>Rate</u>
(a) an aircraft normally engaged in an international flight	VT. 18.000
(b) an aircraft normally engaged in a domestic flight	VT. 9.000
(c) a helicopter normally engaged in an international flight	VT. 9.000
(d) a helicopter normally engaged in a domestic flight	VT. 4.500
(2) The fees payable under subsection (1) shall, subject to subsection (3), be payable by the captain of the aircraft to an authorized officer of the Government at each airport referred to in subsection (1) immediately after the arrival and prior to the departure of the aircraft.	
(3) The fees may, by prior arrangement, be paid to the Department of Civil Aviation by an airline which is responsible for the aircraft in Vanuatu on a monthly basis in respect of landings and take-offs outside official hours made by aircraft for which it is responsible during the previous month.	

- (4) Where the fees are not paid by the airline within 30 days of the due date pursuant to an arrangement made under subsection (3), the Government shall recover the amount due as a civil debt.

**EXEMPTION**

2. The following aircraft are exempt from paying the fees hereinbefore prescribed:

- (a) any aircraft on an international or domestic flight which is used solely for diplomatic purposes;
- (b) any aircraft carrying out a test flight;
- (c) any aircraft landing or taking off due to an emergency.

**REPEAL**

3. The following Orders are repealed -



- (b) The Civil Aviation (Aircraft Special Night Landing and Take-off Fees Regulation)(Amendment No. 1)Order No. 37 of 1985;
- (c) The Civil Aviation (Aircraft Special Night Landing and Take-off Fees Regulation) Order No. 41 of 1986.

**COMMENCEMENT**

4. This Order shall come into force on the 1st day of September, 1987.
