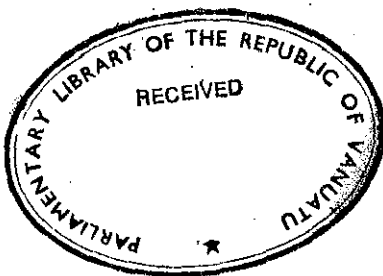

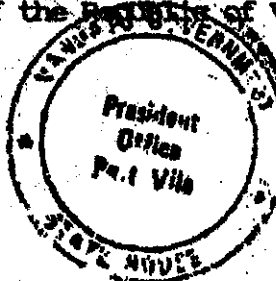
APPOINTMENT

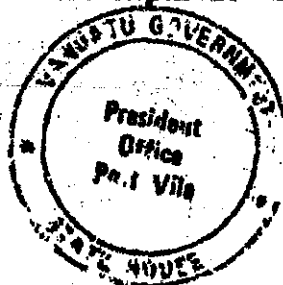
APPOINTMENT






