 - (1) in reference to the island of Maewo by adding a new polling station 1.05.02 E. NAVENEVENE.


COMMENCEMENT





DECENTRALIZATION (DATE OF ELECTION OF AMBAE/MAEWO,
MALEKULA, TONGOA/SHEPHERDS AND TAFEÀ LOCAL GOVERNMENT COUNCILS)

ORDER No. 24 OF 1989

To declare the date for the start of elections for councillors to the Ambae/Maewo, Malekula, Tongoa/Shepherds and Tafea Local Government Councils.

WHEREAS:

- (a) The four year term of the Ambae/Maewo, Malekula, Tongoa/Shepherds and Tafea Local Government Government Councils expires on or about August and September 1989 ; and
- (b) Elections need be held for the named councils in accordance with the Decentralization Act No. 11 of 1980.

NOW THEREFORE, IN EXERCISE of the powers contained in section 8 (2) (a) of the Decentralization Act No. 11 of 1980 as amended, the ELECTORAL COMMISSION HEREBY MAKES the following order ;

DATE OF ELECTION

- (1) The election for councillors to the Local Government Councils of Ambae/Maewo, Malekula, Tongoa/Shepherds and Tafea shall all commence on 30th August 1989.

RETURN OF CANDIDATURE


- (2) Eligible persons may submit their declaration of candidature for the above councils elections as from the date of signature of this order until not later than 4.30 p.m. on the 7th August, 1989 to the Principal Electoral Officer in Vila or to the respective Local Government Council Secretary.



IN EXERCISE of the powers conferred by Section 17A of the Joint Public Order Regulation No. 11 of 1974, I IOLU ABBIL, Minister of Home Affairs, hereby make the following Regulation :-
