ORDER No. 35 OF 1990

To declare the date for the start of elections for councillors to the Banks/Torres, Ambrym, Paama and Epi Local Government Councils.

WHEREAS:

- (a) The four year term of the Banks/Torres, Ambrym, Paama and Epi Local Government Councils expires on or about 25th January, 1991; and
- (b) Elections need be held for the named councils in accordance with the Decentralization Act [CAP. 127].

NOW THEREFORE, IN EXERCISE of the powers conferred by section 8(2)(a) of the Decentralization Act [CAP. 127] as amended, the ELECTORAL COMMISSION HEREBY MAKES the following order;

DATE OF ELECTION

1. The election for councillors to the Local Government Councils of Banks/Torres, Ambrym, Paama and Epi shall all commence on 24th January, 1991.


RETURN OF CANDIDATURE

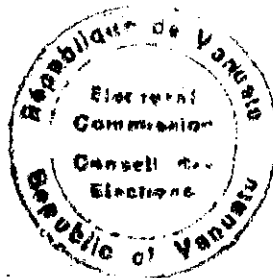
