REPUBLIC OF VANUATU

FORESTRY (REGULATIONS) (AMENDMENT)
ORDER NO. 7 OF 1994

To make certain changes to the second Schedule of the Forestry (Regulations) Order No. 10 of 1984.

IN EXERCISE of the powers conferred upon me by section 34 of the Forestry Act [CAP 147], I, THOMAS BROTHY FARATIA, Minister of Agriculture, Livestock, Forestry and Fisheries, make the following regulations:-

AMENDMENT OF THE SECOND SCHEDULE TO ORDER NO.10 OF 1984

1. The second Schedule to the Forestry (Regulations) Order No. 10 of 1984 is amended -

(a) at the end of the Agreement by deleting the words "Director of Forestry" and substituting the word "Minister";

(b) on the page headed "NOTES" appended to the Agreement -

(i) in paragraph 3 by deleting the words "Director, Department of Forestry" and substituting the word "Minister";

(ii) in paragraph 4 by deleting the word "Director" and substituting the word "Minister";

(iii) in paragraph 5 by deleting the word "Director" and substituting the word "Minister".

(c) in the Special Conditions attached to the Agreement, after paragraph 10 by inserting the following new paragraphs -

"10A. The logged area shall be replanted with trees of (species) at a stocking of trees per hectre (a spacing ofm xm), the location of planting to be agreed on before logging commences and detailed on the attached map.

10B. The company shall be responsible for all costs of initial establishment of the planting programme, care and maintenance of the plantations for the duration of the logging project as specified in the company's project proposal."

(d) at the end of the Special Conditions by deleting the word "Director" and substituting the word "Minister".

COMMENCEMENT

2. This Order shall come into force on the date of its publication in the Gazette.

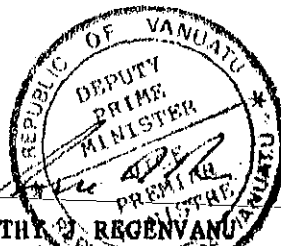

NOW THEREFORE, I CHARLIE NAKO, Minister of Home Affairs and Minister responsible for natural disasters, HEREBY DECLARE -

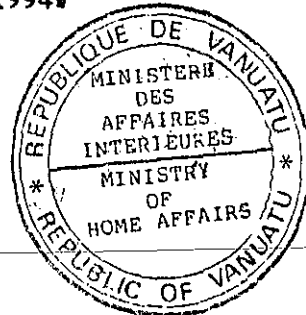
- a) That coastal area of North Efate extending from Lelepa to Epau;
