A R R E T E :

**VENTE DE BOISSONS ALCOOLISEES A VANUATU**

1. Sous réserve des dispositions de l'article 2, la vente, la fourniture et la distribution de boissons alcoolisées dans les débits de boissons de la République de Vanuatu, soit pour consommer sur place soit pour emporter, sont par les présentes interdites entre 7h30 du matin le mercredi 29 novembre 1995 et 7h30 du matin le samedi 2 décembre 1995.

**DEROGATION**

2. Nonobstant les dispositions de l'article 1, les restaurants et les hôtels pourront vendre des boissons alcoolisées durant ladite période, pendant leurs heures normales d'ouverture, aux clients sérieux qui en commandent pour accompagner leur repas.

**ENTREE EN VIGUEUR**

3. Le présent Arrêté entrera en vigueur le 29 novembre 1995.

**IN EXERCISE** of the powers conferred by sections 23 and 24 of the Chambers of Commerce and Industry of Vanuatu Act No 4 of 1995, and following recommendations by the Council of Port-Vila Chamber of Commerce and Industry as said in section 5 of the Chambers of Commerce (Port Vila) Order No of 1995, **I, WILLIE JIMMY**, Minister of Finance, make the following Order:-

**FIRST MEETING OF THE PROVISIONAL COUNCILS OF THE LOCAL CHAMBERS OF COMMERCE AND INDUSTRY.**

3. (1) On or before the expiry of four (4) months from the publication of this Order in the Gazette, each provisional Council shall hold a meeting,

convened by the President of the Chamber of Commerce and Industry of Port-Vila. At this meeting, the Council shall elect its President, two Vice-Presidents, a Secretary and a Treasurer.

- (2) At its first meeting, each Council shall nominate its representatives in the National Council of the Chambers of Commerce and Industry of Vanuatu, according to Section 13 of the Act.


**TERM OF OFFICE OF THE MEMBERS OF THE COUNCILS OF THE LOCAL CHAMBERS OF COMMERCE AND INDUSTRY.**

4. The members of the Councils of the local Chambers of Commerce and Industry will organise their own Constitutions, in respect with Section 18 of the Act. Under these Constitutions, the period of office of the members of the provisional Councils shall not exceed eighteen (18) months.

**COMMENCEMENT.**

5. This Order shall come into force on the date of its publication in the Gazette.
