Prohibition on the Importation of Corrugated Iron Roof
(Amendment)

Order No. 11 of 2005

In exercise of the powers conferred on me by subsection 2(1) of the Import of Good (Control) Act [CAP 176] and subsection 15(3) of the Interpretation Act [CAP 132] to amend an Order made under that Act, I, the Honourable JAMES BULE, Minister of Trade, Commerce, Industry and Tourism make the following Order.

1 Amendments

The Prohibition on the Importation of Corrugated Iron Roof Order No. 14 of 2003 is amended as set out in the Schedule.

2 Commencement

This Order is taken to have commenced on 04 April 2005 and ceases to have effect on 08 April 2005.

AMENDMENTS OF THE PROHIBITION ON THE IMPORTATION OF CORRUGATED IRON ROOF ORDER NO. 14 OF 2003

1 Clause 1A

Insert

- (2) Despite clause 1, the “Youth with Mission” may import into Vanuatu on or before 08 April 2005, 20 pieces of iron roof only (import tariff item 7210 4100).”.

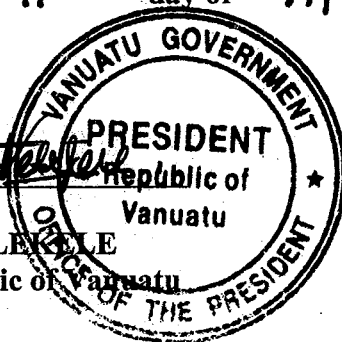

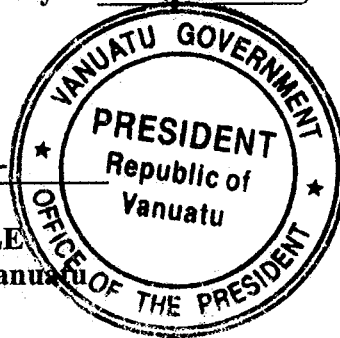

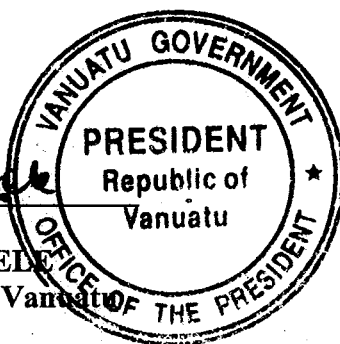
