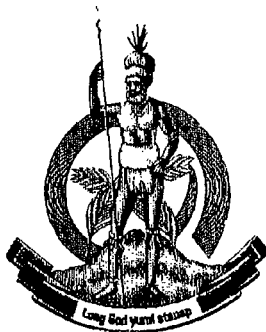

**1 Amendment of Schedule 6 of the Diplomatic Privileges and Immunities Act [CAP 143]**

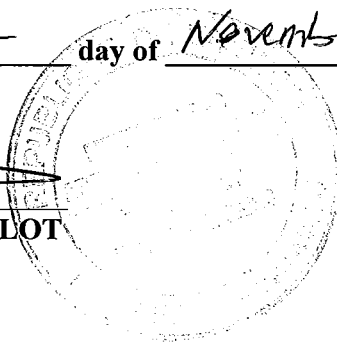
Schedule 6 of the Act is amended as set out in the Schedule.

### DIPLOMATIC PRIVILEGES AND IMMUNITIES ACT [CAP 143]

#### **Regional Representative of the International Organisation for Immigration (IOM) Order No. ~~215~~ of 2011**

In exercise of the powers conferred on me by section 5 and subsections 6(1) and (5) of the Diplomatic Privileges and Immunities Act [CAP 143], I, the Honourable ALFRED CARLOT Minister of Foreign Affairs, make the following Order.

#### **1 Interpretation**

In this order:

**Act** means the Diplomatic Privileges and Immunities Act [CAP 143];

**International Organisation for Immigration (IOM)** means the Organisation as established under the Agreement establishing International Organisation for Immigration.

#### **2 Privileges and Immunities for the International Organisation for Immigration (IOM)**

The International Organisation for Immigration has the privileges and immunities set out in Schedule 2 of the Act and the legal capacities of a body corporate.

**3 Officials of the International Organisation for Immigration (IOM)**

- (1) An officer of the IOM (other than an officer representing the Government of Vanuatu in the IOM) has the privileges and immunities set out in Schedules 3 and 4 of the Act.
- (2) A family member of an officer under subclause (1) is also entitled to the privileges and immunities set out in Schedule 5 of the Act.

**5 Commencement**

This Order commences on the day on which it is made.
