
Instrument of Removal of Minister Order No. 41 of 2015



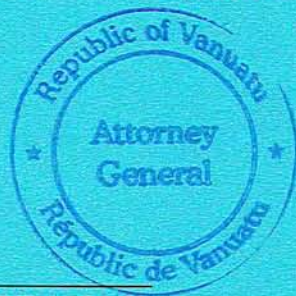

LIQUOR LICENCING ACT [CAP 52]

Liquor Licensing (Prohibition of Sale) Order No. 44 of 2015

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, the Honourable CHARLOT SALWAI TABIMASMAS, Minister of Internal Affairs, make the following Order.

1 Sale of Liquor Prohibited

The sale of liquor in or from licensed premises throughout Luganville whether for consumption on or off such premises is prohibited from 12 o'clock midnight on Monday 20 July 2015 to 12 o'clock midnight on Wednesday 22 July 2015.


2 Exemption

Despite clause 1, liquor may be sold during the period referred to in clause 1 within the normal hours of opening in restaurants, bars and hotels to bona fide customers for consumption with food.

3 Commencement

This Order commences on the day on which it is made.
