THE SAMOA HEALTH AMENDMENT ORDINANCE, 1936.

AN ORDINANCE

made by the Administrator of the Territory of Western Samoa with the advice and consent of the Legislative Council of that Territory, and in pursuance of the Samoa Act, 1921.

- This Ordinance may be cited as "The Samoa Health Amendment Short Title. Ordinance, 1936," and shall come into operation on the first day of April, 1937.
 - 2. In this Ordinance if not inconsistent with the context

 "Abattoir" means any place where animals are killed for the
 purpose of producing meat to be sold either solely or
 - partly for human consumption;

 "Bakery" means any place where bread cakes buns biscuits
 pastry or other similar goods to be sold either solely
 or partly for human consumption are prepared or baked;
 - "Dairy" means any cowshed or other building or any place where cows are stalled or kept for the purpose of milking in order to produce from such cows either solely or partly for human consumption any milk, cream, or butter.
- 3. If shall be the duty of the owner or occupier of any abattoir Premises to bakery or dairy to procure annually from the Chief Medical Officer a be idensed, license to use the same as an abattoir bakery or dairy respectively.

Condition precedent 4. A license to use an abattoir bakery or dairy shall not be issued unless the fees hereinafter prescribed shall have first been paid and the Chief Medical Officer is satisfied that the premises sought to be licensed are capable of being used as an abattoir bakery or dairy as the case may be without dancer to the nublic health.

Fees|payable

5. The fees payable for the issue of an abattoir bakery or dairy license shall be the amounts prescribed in the schedule hereto.

Duration of

6. Save as hereinafter provided every license issued under this Ordinance shall remain in force until the 31st day of March next after the date on which it was issued and shall then expire.

Unlicensed Premises not 7. No person shall use or permit to be used any abattoir bakery or dairy unless a license to use the same as such has been issued under this section and remains in force.

Offences

- 8. (1) Any person who uses an abattoir bakery or dairy or permits the same to be used in contravention of the provisions of the last preceding section hereof commits an offence and shall be liable to a penalty of £10 for every day or part of a day during which the offence shall continue.
- (2) Every owner occupier or manager of an abattoir bakery or dairy who fails to keep the same and all appliances used in connection therewith in a clean and sanitary state and condition is guilty of an offence and shall be liable to a penalty of £20.

Closing

9. If in the opinion of the Chief Medical Officer any shop premises or other place wherein any foodstuffs food or drink is sold or is prepared or manufactured for sale either solely or partly for human consumption are not capable of being so used without danger to public health he may issue a closing order in respect of such shop premises or place and the provisions of Sections 5, 6, 7, 8, and 9 of "The Samoa Health Ordinance, 1921," shall mutatis mutantis apply to any such order.

Offence

10. Every person being the owner or occupier of any shop premises or place in respect of which a closing order under the last preceding section is in force who carries on or permits to be carried on therein or any part thereof the business of selling or preparing or manufacturing for sale food or drink solely or partly for human consumption commits an offence and shall be liable to a penalty of £20 for every day or part of a day during which the same shall continue.
